It is submitted with respect in the above said subject and reference that, at the place of work, the Sexual Harrassment Of Women At Workplace (Prevention, Prohibition And Redressal) Act, 2013 and rules dated 9.12.2013, has been notified. Under this act, under section 4 (i) there is provision for appointing complaint committee. Under this act, in Chapter I of Section 2 as per the explanation mentioned at every Govt. / Semi Govt., office, organization, corporation, establishment, society branch, similarly, in private sector, organization or private undertaking / institute, enterprises, non Govt. Institutes, societies, trusts, producer, supplier and distributors and commercial place of sale,

industrial, educational, entertainment, industrial, health services or financial units, supplier of services, hospitals, welfare centres, sports, societies, halls, sports complex, etc. all such establishments / in offices, it is necessary to appoint committee. How to establish the committee is mentioned under The Sexual Harrassment of Women at Workplace (Prevention, Prohibition and Redressal) Act, 2013 and rules therein and as per Govt. Decision dated 19.6.2014, for your information, the same is attached. Therefore, in your establishment, if there are 10 or more than 10 workers, then appoint committee and in the prescribed format, the report of committee is to be submitted in this office immediately.

The Sexual Harrassment of Women at Workplace (Prevention, Prohibition and Redressal) Act, 2013 at the place of work and U/s. 26 (i) (c) the appointment of committee if not done, then employer will be liable for the penalty of Rs. 50,000/-as it is the provision. Thereafter, if it is informed again and again even then, committee is not appointed, then whatever Govt. Machinery will be applicable according to that, the license of your office or the business for conducting further activities may be stopped, for which take note.

Therefore, as per the Act, appoint the committee in prescribed format and submit report in this office prior to 20.07.2019.
