ORDER

- 1. Whereas the Government of National Capital Territory of Delhi, had last revised the minimum rates of wages in Scheduled Employments under the Minimum Wages Act, 1948 in the National Capital Territory of Delhi vide notification No. Addl.LC/Lab/MW/2016/4859 dated 03.03.2017.
- 2. And whereas, in the abovementioned notification it was stipulated that the Dearness Allowance will be payable on the basis of six monthly average index numbers of January to June and July to December, on 1st April and 1st October respectively.
- And whereas, the Hon'ble High Court of Delhi in the matters WPC 8125/2016, Federation of Okhla Industrial Association Vs. Lt. Governor of Delhi ANR. and other matters has quashed notification No. F.Addl.LC/Lab/MW/2016/4859 dated 03.03.2017 vide judgment dated 04.08.2018.
- 4. And whereas, the GNCT of Delhi has filed SLPs no. 26185-26228 of 2018, GNCT of Delhi Vs. FLT LT. Rajan Dhall Charitable Trust and Ors., which have been admitted and Hon'ble Supreme Court vide its order dated 31.10.2018 has upheld the minimum rates of wages notified vide notification dated 03.03.2017 for a period 3 months.
- 5. And whereas, GNCT of Delhi in compliance of order dated 31.10.2018 has placed before the Hon'ble Supreme Court, proposed rates of minimum wages which were arrived at a fresh under section-5(1)(b) of M.W. Act, 1948 and after notifying Minimum Wages Advisory Board u/s-7 of M.W. Act, 1948. The Hon'ble Supreme Court vide its order dated 14.10.2019 has allowed the proposed notification regarding enhancement of minimum wages which will be applicable from the date of notification.
- 6. And whereas, the dearness allowance w.e.f. 01.04.2019 and 01.10.2019 has become due, the Government of National Capital Territory of Delhi after adjustment of the average Consumer Price Index Number from the period from July 2018 to December 2018 which is 301.33, an increase of 13 points and from January to June, 2019 which is 310.83, an increase of 9.5 points, hereby declares the following Dearness Allowance, which shall be payable for all categories of workers w.e.f. 01.04.2019 and 01.10.2019 respectively. The rates after including both installments of D.A. (April & October, 2019) shall be as follows for different categories of workers in all schedule employments:-
