As per the Notification No.DES/1036/2023-P3(1),The Consumer Price Index (Cost of Living Index) Numbers applicable to employees in employment under the Minimum Wages Act (Central Act XI of 1948) for the month of January 2024 as ascertained by the Director General of Economics & Statistics under clause (C) of Section 2 of the Act.
