**NOTIFICATION**

WHEREAS, the proposal for revision of minimum rates of wages payable to the employees employed in Shops & Establishments in the Union Territory of Puducherry, was published as required under clause (b) of sub-section (1) of Section 5 of the Minimum Wages Act, 1948 (Central Act 11 of 1948) in Notification issued by the Labour Department vide G.O.Ms.No.27/AIL/Lab/G/2023, dated 14.08.2023 and published in the Official Gazette of Puducherry No.35, dated 29.08.2023, inviting objections and suggestions from all the persons likely to be affected thereby, within sixty days from the date of publication of the said Notification in the Official Gazette of Puducherry;

AND WHEREAS, pursuant to the said Notification, objections/ suggestions received within the above said stipulated time limit have been considered in depth;

AND WHEREAS, in pursuance of the proviso to sub-section (2) of Section 5, the Minimum Wages Advisory Board constituted under Section 7 of the said Act, has also been consulted with regard to the aforesaid revision of minimum rates of wages;

AND WHEREAS, after consideration of the grievance on the minimum rates of wages notified in the preliminary Notification and pursuant to the consensus arrived between the Employees and Employers Representative of the Advisory Board, the Minimum Wages Advisory Board unanimously resolved to recommend to increase the aforesaid revision of minimum rates of wages;

NOW, THEREFORE, in exercise of the powers conferred under clause (b) of sub-section (1) of Section 3 read with sub-section (2) of Section 5 and sub-section (1) of Section 13 of the Minimum Wages Act, 1948 (Central Act 11 of 1948) and in supersession of the Notification issued vide G.O.Ms.No.09/AIL/Lab/G/2016, dated 22.08.2016 of the Labour Department, Government of Puducherry and published in Gazette of Puducherry No. 36, dated 06.09.2016, the Lieutenant-Governor, Puducherry, is pleased to revise the minimum rates of wages payable in respect of the employees employed in Shops & Establishments in the Union Territory of Puducherry as specified in the Schedule hereunder:-



**NOTE:**

1. Dearness Allowance:- In addition to the above minimum rates of wages fixed herein, the employees shall be paid Dearness Allowance as indicated below:
  - (i) The Dearness Allowance shall be linked to the Average of Puducherry City Consumer Price Index Points for the year 2023 that is 426 points (with base year 2001=100) and for every raise of one point over and above 426 points, an increase of Rs.32.40/- (Rupees Thirty Two and paise Forty only) per point per month shall be paid as Dearness Allowance.
  - (ii) The Dearness Allowance shall be calculated on the 1<sup>st</sup> April of every year on the basis of the average of the indices for the preceeding twelve months i.e. from January to December.
  - (iii) The first calculation shall thus be effective from the date of publication of this Notification in the Official Gazette of Government of Puducherry, based on the average of the Puducherry City Consumer Price Index points for the previous year.
2. To arrive at the daily rates of wages, the monthly rate of wages shall be divided by 26.
3. Where the nature of work is the same, no distinction in the payment of wages shall be made between male and female employees.
4. Wherever the existing wages are higher than the minimum rate of wages fixed herein, the said existing higher wages shall be continued to be paid.

The Notification shall come into force on and from the date of its publication in the Puducherry Government Gazette.



- (ii) The Dearness Allowance shall be calculated on 1<sup>st</sup> April of every year on the basis of the average of the indices for the preceeding twelve months, i.e from January to December.
- (iii) The first calculation shall thus be effective from the date of issue this Notification in the Official Gazette of Government of Puducherry, based on the average of the Puducherry City Consumer Price Index for the previous year, that is, from January to December.

- (2) To arrive at the daily rates of wages, the monthly rate of wages shall be divided by 26.
- (3) Where the nature of work is the same, no distinction in the payment of wages shall be made between male and female employees.



  - ii. The first calculation shall thus be effective from the date of issue of this Notification in the Official Gazette of Government of Puducherry, based on the average of the Puducherry City Consumer Price Index for the previous year.
